ORDER

- 1. The colleges mentioned in para (6) below have submitted application for starting of new Pharmacy college/ enhancement of seats for the academic year 2020–21 based on the orders of Hon'ble High Court of Kerala read as (1) above.
- 2. University vide UO read as (2) to (6) above constituted inspection commission to conduct inspection in these colleges to assess the facilities for the conduct of the Pharmacy courses. Inspection teams conducted inspections and submitted their reports..
- 3. On scrutiny of the inspection reports, the scrutiny committee vide paper read as (3) above recommended for starting of new Pharmacy course / enhancement of seats in existing courses in the colleges..
- 4. All the said colleges are having permission from the PCI for the conduct of the courses mentioned below for the year 2020-21. The colleges paid the required fee for provisional affiliation and fee for refundable deposit.



5. The Hon'ble Vice Chancellor has accorded sanction to grant Provisional Affiliation to the colleges during the year 2020–21 subject to ratification by the Governing Council

7. The colleges shall strictly adhere to the conditions detailed below.

- i) Affiliation granted is subject to satisfactory legal scrutiny reports of the land documents submitted by the institution and the registration of the students admitted in the college is subject to approval from AFRC.
- ii) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be cancelled.
- iii) In the light of the direction of the Supreme Court of India in WP(C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- iv) Affiliation granted is strictly provisional and only for the academic year 2020–21. The College has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- v) Admission to the next academic year shall be made only after obtaining prior permission from the University.



- vi) College has to remit annual administration fee fixed for UG Course during 2020-21.
- vii) College shall collect fees (One time payment at the time of admission) from the students to be remitted to the University as follows (College is bound to remit the fees prescribed by the university from time to time).
