



- b. The members of the executive committee shall be elected by the members of the association at the Annual General Body Meeting (AGBM) and they shall hold office for a period of two years.
- c. A committee once elected shall continue to hold office till a new committee assumes charge.
- d. If any vacancy arises in any post on account of resignation, death etc., the executive committee may nominate any person to such post from among the members of the executive committee. Such nominated persons shall hold office till the next election of the executive committee.
- e. If an executive committee member is absent from three consecutive meetings of the executive committee, without prior notice, he / she shall cease to be a member of the executive committee.
- f. The Executive committee shall have the power to expel a member for wilful disregard to the association rules or misconduct, on provided the member concerned gives an acceptable explanation for his / her misconduct.

- b. The procedure for election shall be laid down by the executive committee.
- c. All terms of office of the elected members shall commence from the close of the AGBM at which elections were held and shall continue for a period of TWO YEARS or till the close of the second AGBM leaving one inbetween, whichever is earlier.

9. Executive Committee Meetings

- a. Meetings of the Executive Committee shall ordinarily be convened at least once in 3 months.

10. General Provisions regarding meetings.

- a. Seven days'notice shall ordinarily be given for all meetings of theexecutive committee.
- b. Thirty days'notice shall ordinarily be given for all meetings of the general body. The notice of the General Body meeting shall be published in official web site of the college.
- c. In the absence of the president, the vice-president shall preside over the meetings of the general body / executive committee. In the absence of the President and Vice-President, any member appointed by theexecutive committee shall preside over the meeting.
