



MEMORANDUM OF UNDERSTANDING BETWEEN
NIRMALA COLLEGE OF PHARMACY, MUVATTUPUZHA, KERALA
AND
CHEMISTS COLLEGE OF PHARMACEUTICAL SCIENCES AND RESEARCH,
VARIKOLI, KOCHI, KERALA

This document constitutes a Memorandum of Understanding (MOU) between Nirmala College of Pharmacy, Muvattupuzha, Kerala and Chemists College of Pharmaceutical Sciences and Research, Varikoli, Puthencruz, Kochi, Kerala (hereinafter referred to as "the two Institutions") have jointly developed this memorandum of understanding to collaborate for a program of co-operation. This understanding is being required as part of implementation of the scheme 'MARGDARSHAN' supported by AICTE, New Delhi and other such activities with the mutual interest and participation.

The two Institutions jointly agree as follows:

1. The two institutions agree to facilitate the AICTE sponsored Faculty Development Programme (FDP) or Guest Lectures under the scheme MARGDARSHAN, where the Nirmala College of Pharmacy, Muvattupuzha, Kerala will be identified as Mentor institution and Chemists College of Pharmaceutical Sciences and Research, Varikoli, Puthencruz, Kochi, Kerala will be represented as Mentee Institute.
2. In order to ensure the good management of the activities under the MARGDARSHAN Program the Mentor Institute will appoint one Chief co-coordinator and mentee institute will appoint one co-coordinator to ensure the day-to-day operation of this program. These co-coordinators must be the full time faculty member of the institute.
3. To fulfill the objective of this MOU, Dr. Bharat Mishra, Professor & Head, Department of Pharmacology, Nirmala College of Pharmacy, Muvattupuzha (Mentor Institute) will be appointed as the Chief co-coordinator and Dr. Limce Thampi, Associate Professor, Chemists

College of Pharmaceutical Sciences and Research, Varikoli, Puthencruz, Kochi, Kerala (Mentee Institute) appointed as the co-coordinator.


4. The two institutions agree to promote exchange and co-operation in all appropriate and agreed academic areas of research and teaching, the development of new areas of research and teaching, professional development programs and the sharing and dissemination of information and documentation in areas of mutual interest.
5. The two institutions agree to facilitate exchange of and co-operation between the staff of both Institutions in research, publication, teaching, supervision and examination of students, mounting of conferences and other areas of mutual interest.
6. The two Institutions agree to discuss the mobility of students willing to visit and/or to participate in the education programs of both the Institution.
7. This Memorandum of Understanding shall be effective for Three years; from the date of signing in the first instance and shall be subject to change, renewal and termination by mutual consent. A party may terminate this Memorandum of Understanding for convenience and at any time and for any reason by giving three months' notice in writing to the other party.
8. The MOU will be amended with the consent of the two institutions as a written appendage executed by authorized individuals of both institutions. Such appendage once approved by both institutions will become part of this MOU.
9. This Memorandum of Understanding shall be construed and governed in accordance with the laws of India.
10. In case of the involvement of funds for initiation, conduction and development of the specific activities, the separate Memorandum of Agreement (MOA) can be signed between the two institutions.
