7. The agreement is to be in effect at least for ten years from the time of its endorsement by both the parties



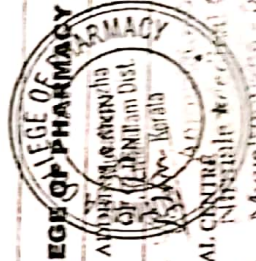
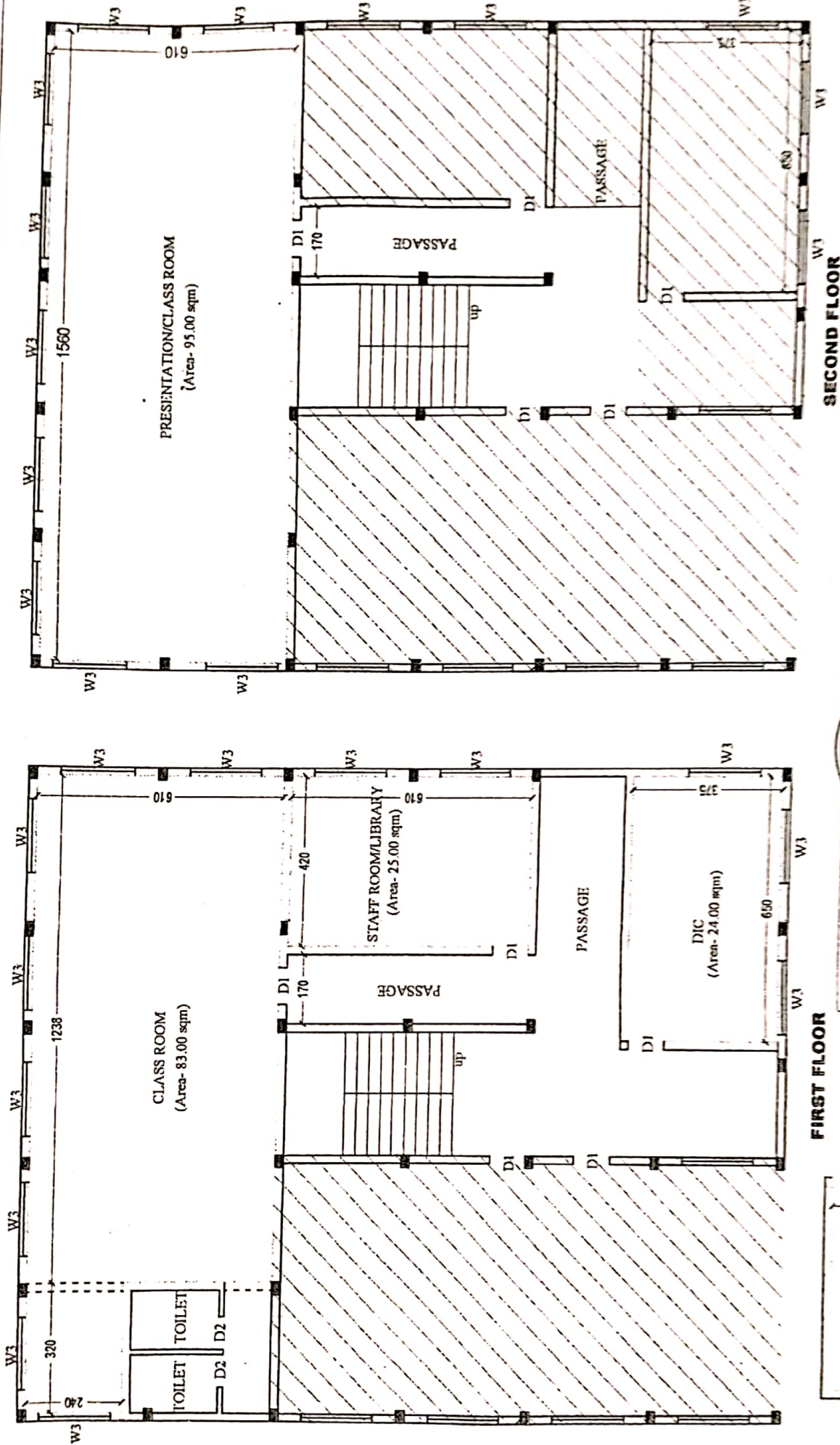
